



HANDLING OPERATIONAL INFORMATIONS

The 36th World gliding championship 2020 will take place at Ecury sur Coole (51240) airfield from August 08th 2020 till August 22nd 2020



Preferred port of arrival & customs formalities

Ecury sur Coole airfield is located 400 km far from LE HAVRE French port east side.

All seafreight containers must be booked to LE HAVRE French port as final destination. IMPECO FRANCE SAS can support you for bookings all over the world.

Concerning customs formalities, ATA carnets are strongly recommended.



Schedule of operations (import side):

- July 31st 2020: Grounding of the containers from 08:00 AM.
During grounding operations, the grounding area will stay closed till the end of last container handling.
For a security reason, no access will be permitted during handling operations.
- August 01st 2020: Teams will have access to their containers from 08 :00 AM

Temporary storage:

A prior « waiting zone » will be organised from July 20th till July 30th at Le Havre port
All containers will be stored there from arrival till July 30th 2020.
On July 31st 2020, containers will be delivered and grounded at Ecury sur Coole Airfield.

Costs of ocean freight & handling operations (import side):

Indicated prices are calculated upon total of 5 containers and can be readjusted, depending on total quantity of containers.

- Ocean freight: To be quoted following departure countries
- THC Le Havre port: 250.00 € per container
- Customs formalities: 100 € per ATA carnet
- Grounding / loading operations at Le Havre port: 150.00 € per container (unload & reload)
- Storage from July 20th till July 30th 2020: 150.00 € per container
- Cartage from Le Havre to Ecury sur Coole: 1 200.00 € per container per trip
- Crane services at Ecury sur Coole 600.00 € per container (per movement)

Collection of the containers after the event (export side):

Collection of the containers, after the world championship, will start on Tuesday Aug. 25th 2020
08 :00 AM.

All participants must have their containers repacked and ready for collection on Monday August 31st
08 :00 PM latest deadline.

IMPECO France will seal each container with a sea line seal on Tuesday morning before collection.



Costs of ocean freight and handling operations (export side):

Indicated prices are calculated upon total of 5 containers and can be readjusted, depending on total quantity of containers.

- Customs formalities: 100 € per ATA carnet
- Grounding / loading operations at Le Havre port: 150.00 € per container (unload & reload)
- Cartage from Le Havre to Ecury sur Coole: 1 200.00 € per container per trip
- Crane services at Ecury sur Coole 600.00 € per container (per movement)
- THC Le Havre: 250.00 € per container
- Ocean freight: to be quoted following destination countries
